AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF

ORLANDO - APOPKA AIRPORT, A COMMERCIAL LAND CONDOMINIUM

This AMENDMENT is made this $\underline{\phi}$ day of February, 2006, by ORLANDO COUNTY AVIATION SERVICE, INC., a Florida corporation ("Developer").

WHEREAS, The Declaration of Condominium of Orlando - Apopka Airport, a Commercial Land Condominium ("Declaration") was recorded in O.R. Book 7431, page 1846 of the Public Records of Orange County, Florida; and

WHEREAS, ORLANDO COUNTY AVIATION SERVICE, INC. is the Developer as described in the Declaration; and

WHEREAS, pursuant to Article XIV, Section 4 of the Declaration, the Developer may amend the Declaration; and

WHEREAS, Developer desires to amend the Declaration to correct certain scriber's errors in the Declaration,

NOW, THEREFORE, the Declaration is hereby amended as follows:

- 1. Article II, Sections 2, 3, & 7, Article VII, Exhibit A and Exhibit D. Article II, Sections 2, 3, & 7, Article VII, Exhibit A and Exhibit D are hereby amended such that any reference to "Orlando Country Airport Land Condominium Owner's Association, Inc." is amended to read "Orlando Apopka Airport Association, Inc." and any reference to "Orlando Country Airport, a Land Condominium" is amended to read "Orlando Apopka Airport, a Phased Commercial Land Condominium".
- 2. **Exhibit E.** The last sentence in Exhibit E is hereby amended to read: "Each Unit shall have a corresponding number of votes in the Association, based upon 176 total Association votes. The total number of votes in the Association shall be 176 at all times.
